If my dog/s are brought to daycare with fleas or ticks, the staff at K9 Kaos LLC will treat my dog with a flea bath at my expense. I understand that if I do not pick up my dog before 6:30 pm, I will be charged a late fee of \$10.00 from 6:31 pm to 6:45 pm and an additional \$10.00 for every 15 minutes thereafter. I understand that if I do not call to cancel regularly scheduled daycare before 7:30 am on the scheduled day, I will be charged for that day.

**WAIVER, ASSUMPTION OF RISK, AND AGREEMENT TO INDEMNIFY AND HOLD HARMLESS**

I understand that attendance at a dog service facility is not without risk to my dog/s, myself, members of my family or guests who may attend. Any dog/s to which I (we) may be exposed may be difficult to control and may be the cause of injury even when handled with the greatest amount of care.

I understand that my dog/s will participate in group dog playgroup daycare program. I understand that even with extreme care in choosing groups and monitoring play sessions, that injuries can happen. I hereby agree to indemnify and hold harmless K9 Kaos, LLC, its employees, owners, agents, and other dog owners from any and all claims, or claims made by any member of my family or any other person in relation to any and all injuries that may occur.

I hereby waive and release K9 Kaos, LLC, its employees, owners, and agents from any and all liability of any nature, for injury or damage which I or my dog/s may suffer, including specifically, but not without limitation, any injury or damage resulting from the action of any dog/s. I expressly assume the risk of any such damage or injury while attending any daycare, grooming, training, program, or other function of K9 Kaos, LLC, or while on the grounds or the surrounding area.

If my dog/s becomes ill or injured, I hereby waive and release agents for K9 Kaos, LLC, its employees, owners, and agents from loss or damage from disease, death, escape, theft, fire, injury, injury to persons, other dogs or property by said dog/s, or other unavoidable causes.

If a dog/s is left unclaimed, K9 Kaos, LLC retains the right, after 5 days and after written notice to the owner's address of record, to find suitable permanent housing, turn over to a local animal shelter, or dispose of said dog in a humane way. All expenses during this holding period will be the owner's liability regardless of the end result.

I represent that I am the legal owner of said dog/s, that title to said dog is not mortgaged in any way, and that said dog/s has not been exposed to distemper, rabies, kennel cough, parvovirus, or other known contagious diseases within the last thirty days. I also attest that said dog/s is free of worms, heartworm, and fleas (if fleas are found, bathing will be done at the owners expense).

**K9 KAOS POLICIES AND PROCEDURES**

Because K9 Kaos is dedicated to creating a happy and healthy environment for your dog, it is important that our customers understand and follow our policies and procedures. Thank you so much for your patronage, your dogs are like our family.

**Fecal Examinations**

K9 Kaos requires a fecal examination for every dog starting and currently attending K9 Kaos daycare. Each dog will need a fecal exam with negative results performed annually. If your dog should test positive for any parasite you must complete the treatment and then provide proof of a negative fecal before returning to daycare.

**Boarding and Canine Cough**

Please help us avoid an exposure to this very contagious virus. If your dog will be in a boarding facility please plan to take seven full days off from daycare after you return home from your trip. We also strongly encourage you to vaccinate your dog for canine cough every six months as opposed to annually. If your dog has been coughing at all, or if you think your dog was choking on a bone during the night, please do NOT bring them to daycare. Canine cough is tremendously contagious and your dog can be exposed to the virus by just meeting an infected dog on a walk. Please help to keep K9 Kaos 'canine cough free'.

**General Health**

If your dog is ill or has diarrhea please do not bring them to daycare. Instead, please consult with your veterinarian to determine the problem and treatment plan.

**Flexi Leashes**

We all appreciate how handy Flexi leashes are for giving the dogs a certain degree of freedom, while maintaining the control of a leash. Unfortunately, this "degree of freedom" represents some challenges for us in our small store and entrance lobby. We kindly ask that you not use your Flexi leash for daycare; a regular leash is very much appreciated.

**Cancellations**

Please understand that we require a phone call to cancel your scheduled daycare by 7:30 am the morning of your planned visit. The 7:30 am deadline applies for those dogs attending the afternoon half day session as well. You can call and leave a message at any time day or night. Because we are full every day and turn many dogs away, failure to cancel by 7:30 am will result in a charge for your missed visit.

I agree to all of the above and that this contract is in effect beginning on the date below and shall remain in effect on all future dates that said dog/s attends daycare, grooming, training or any other K9 Kaos, LLC function.
